NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MoU, THE PARTIES HERE TO AGREE AS FOLLOWS:

CLAUSE 1

CO-OPERATION

1.1. Both Parties are united by common interests and objectives and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institution and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.

- 2.2. Curriculum Design: Second Party will give valuable inputs to the First Party in teaching / training methodology and suitably customize the curriculum so that the students fit into the industrial scenario meaningfully.
- 2.3. Industrial Training & Visits: Industry and Institution interaction will give an insight in to the latest developments / requirements of the industries; the Second Party to permit the Faculty and Students of the First Party to visit its group companies.
- 2.4. Skill Development Programs: Second Party to train the students of First Party on the emerging technologies in order to bridge the skill gap and make them industry ready.
- 2.5. Guest Lectures: Second Party to extend the necessary support to deliver guest lecturers to the students of the First Party on the technology trends and in house requirements.
- 2.6. both Parties may terminate this MoU 4.2. For scademic year 2019-2020-2020-2021 to 2021-2022 upon 30 calendar days notice in writing. In the event of Termination, both parties have to discharge their obligations.

At the last session of programme Shirsath sir start his training programme with substrate SpawnProduction, Step by step he was trained students. CompostPreparation, Spawning, SpawnRunning, Casing, Fruiting.

With this all-step training was over. Vijay sir distributes the spawn to the students to try the mushroom cultivation at home.




