

Kale sir are invited as chief guest. Principal Dr. S. V. Jadhav sir was the chairperson for the workshop. At the start of workshop R.S. Mohod gave the brief introduction of guest and preface of the programme . In the first session of workshop Dr. A.S. Kale gave the knowledge and history of the patent he also explain enthusiastically about the patent and three types of patent ,he also explain the law of patent & gave brief information regarding to Novelty And Non-Obviousness, Conditions For Obtaining A Patent and and what can be patented. And also gave in formation about the Functions of the United States Patent and Trademark Office. What Are Patents, Trademarks, service marks, and Copyrights? Some people confuse patents, copyrights, and trademarks. Although there may be some similarities among these kinds of intellectual property protection, they are different and serve different purposes Scientific and Technical Information Center, Public Search Facility, and Patent and Trademark Resource Centers. He gave brief introduction about The preparation of an application for patent and the conducting of the proceedings in the United States Patent and Trademark Office to obtain the patent is an undertaking requiring the knowledge of patent law and rules and Office practice and procedures, as well as knowledge of the scientific or technical matters involved in the particular invention.

Inventors may prepare their own applications and file them in the USPTO and conduct the proceedings themselves, but unless they are familiar with these matters or study them in detail, they may get into considerable difficulty. While a patent may be obtained in many cases by persons not skilled in this work, there would be no assurance that the patent obtained would adequately protect the particular invention. At the end he explain Who May Apply For According to the law, the inventor, or a person to whom the inventor has assigned or is under an obligation to assign the invention, may apply for a patent, with certain exceptions. If the inventor is deceased, the application may be made by legal representatives, that is, the administrator or executor of the estate. If the inventor is legally incapacitated, the application for patent may be made by a legal representative (e.g., guardian). If an inventor refuses to apply for a patent or cannot be found, a joint inventor may apply for a patent as joint inventor. If two or more persons make an invention jointly, they apply for a patent as joint inventor and cannot be joined in the application as an inventor. It is possible to correct an innocent mistake in erroneously omitting an inventor or in erroneously naming a person as an inventor.
